#### "CORNERSTONES OF DEMOCRACY: CIVICS, CIVILITY, AND COLLABORATION"

An annual series of events celebrating our legal system, Law Day has special significance in Highlands County. Our courts are in recess as we hold our Law Day observance and focus on students and their civic education. Many county, circuit, and district judges, as well as Florida Supreme Court justices, have attended our local Law Day program.

Information and entry forms for student contests are enclosed with this packet. The prizes for these contests include monetary awards of \$100 for first place, \$50 for second place, and \$25 for third place in each respective category. Prizes are awarded by Highlands County Circuit Court Judge Angela J. Cowden at our Law Day ceremony. Teachers and students will be requested to attend the award ceremony to be recognized, allowing parents and the press an opportunity for photographs.

Winning posters will be displayed on the front windows of the Highlands County Government Center.
